## Class of 2024 News

- **COMPLETING A LOAN "EXIT SESSION"** during your T4 year is a mandatory graduation requirement for [federal loan borrowers](#) and can be satisfied via your successful completion of one of the following events:
  - Scheduling and meeting with your Tulane financial aid counselor for a loan "Exit Session"; [OR](#)
  - Attending a School of Medicine IDS session on Loan Repayment and Debt Management; [OR](#)

- **2023 TAX RETURN:** This is an early notice that you need to plan on completing a 2023 tax return even if you did not earn any income. Doing so will help you plan for loan repayment during your residency. 2023 tax returns will be used to determine your monthly loan payment amount for income-driven plans. Look for upcoming information regarding a Tax Filing session this spring.
